Website Status: Website is up and running.

- November Avon Fundraiser has begun, and will run through November 19, 2016
- Tax-exempt Status: Our Form 1023 requesting tax-exempt status for the Foundation was filed on 07/19/2016 with the U.S. Internal Revenue Service. An acknowledgment letter dated 08/04/2016 was received from IRS in response. As of the date of this meeting we have not received our determination letter.
- New York State registration status: On 10/20/2016, the Foundation received electronic notice from the New York State Attorney General's office requesting we complete the Foundation's registration by providing a copy of our tax-exempt status determination letter from IRS. A reply was sent on 10/21/2016, by U.S. Certified Mail, stating we had not yet received our determination letter. In the reply, the Foundation stated a copy of the determination letter would be forwarded to the NYS AG's office when it was received.
- Financial Update
 - Per last month's meeting, a third account was opened to maintain separate funds for the scholarship program. \$500.00 was transferred from the main Foundation account into the new scholarship account.
 - October income report:
 - \$451.34 in direct donations (This includes \$1.34 from the Website electronic donations page from test donations used to test functionality)
 - \$432.60 from the Buffalo Wild Wings October Fundraiser
 - \$0.19 interest earned in deposit accounts
 - October distributions, as authorized at the Board Meeting of 09/28-29/2016:
 - Maria Fareri Children's Hospital (MFCH), Family Resource Center
 - \$100 Mobil Gas Cards
